Please note that this sample NJSBA petition is offered to candidates for board office to assist the school election process in New Jersey. However, candidates should be aware that certain counties require the filing of a county-specific nominating petition. In addition, due to the ongoing state of emergency declared in response to the COVID-19 pandemic, the requirements for filing a nominating petition may be revised pursuant to statute, regulation, or executive order. Pursuant to Executive Order 216, during the ongoing aforementioned public health emergency, nominating petitions may be submitted with handwritten signatures and signatures collected via an online form. Furthermore, nominating petitions may be delivered for filing via hand delivery and electronically. 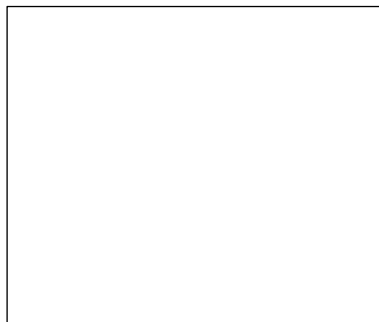

QUALIFICATIONS - Candidates filing a nominating petition for board membership must meet the following qualifications:

- a citizen of the United States of America
- at least 18 (eighteen) years of age to qualify for office
- able to read and write
- a resident of the district, or of such constituent district of a consolidated or regional district as may be required by law, from which he/she is to be elected for at least one year preceding the date of the election
- not disqualified as a voter pursuant to *N.J.S.A. 19:4-1*
- a registered voter in the district
- not convicted of a disqualifying crime pursuant to *N.J.S.A. 18A:12-1*

No board of education member shall be directly or indirectly involved in any contract with, or claim against, the board.

IMPORTANT INFORMATION

- Within 30 days of election or appointment to the board, a member must undergo a **criminal history background investigation** through the New Jersey Department of Education.
- The School Ethics Act and nepotism legislation impact the ability of board members who have relatives working in the school district to act in areas such as personnel and collective negotiations. Please consult your board secretary for details.
